

List of Eligible Applicants for Grant Programs:

A. [Section 5303 / 5304 Metropolitan Planning and Statewide Planning Program](#)

- Funding Recipients / Managers: NCDOT PTD
- Eligible subrecipients: NCDOT and Metropolitan Planning Organizations (MPOS)

B. [Section 5307 Urban Area Formula Program](#)

- Funding Recipients / Managers: Large / Extra Large UZAs; NCDOT PTD (Small UZAs in Governor's Apportionment)
- Eligible subrecipients: designated recipients that are public bodies with the legal authority to receive and dispense federal funds as well as Community Transportation providers operating inside the Urbanized Area. These Designated Recipients will transfer funds to NCDOT PTD and NCDOT PTD will provide funding and oversight for the Community Transportation systems. Non-Profit Organizations are not eligible to receive 5307 funds unless they are utilizing funds for Job-Access or Reverse Commute (JARC)-like activities and have approval from FTA.

C. [Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities Program](#)

- Funding Recipients / Managers: Large / Extra Large UZAs; NCDOT PTD (Small UZAs and rural areas)
- Eligible subrecipients: states or local government authorities, private non-profit organizations, or operators of public transportation. Eligibility and eligibility requirements are discussed in PTD's procedures. Non profit organizations are only eligible to purchase transportation services from the designated 5311 subrecipient or mobility management activities.

D. [Section 5311 Rural Formula Grant Program](#)

- Funding Recipients / Managers: NCDOT PTD
- Eligible subrecipients: NCDOT is the designate recipient. A designated subrecipient is identified in the 5 year planning process or an intercity bus provider.

E. [Section 5339 Bus and Bus Facilities Program](#)

- Funding Recipients / Managers: Large / Extra Large UZAs; NCDOT PTD (Small UZAs and rural areas)
- Eligible subrecipients: NCDOT is the designate recipient. Small urban operators and rural subrecipients.

F. Urban State Match

- Funding Recipients / Managers: Transit providers operating in urbanized areas

G. Rural Operating Assistance Program (ROAP)

- Funding Recipients / Managers: Each County is provided a ROAP allocation.
- Eligible subrecipients: The County may designate ROAP funds to the transportation provider in its County.

H. State Maintenance Assistance Program (SMAP)

- Funding Recipients / Managers: Operators of fixed-route service in large or small urbanized areas as well as large universities that receive state or federal assistance from NCDOT-PTD.
- Eligible subrecipients: None

I. Travel Demand Management (TDM)

- Funding Recipients / Managers: PTD designates one funding recipient for TDM funds in the following areas: Wilmington, the Triangle, The Piedmont Area, Charlotte, and Asheville.
- Eligible subrecipients: The TDM program managing the Triangle Area is allowed to distribute funds to local TDM programs in the Triangle-area.

J. Urban Technology

- Funding Recipients / Managers: Transit providers operating in urbanized areas.

K. Travelers' Aid

- Funding Recipients / Managers: Private non-Profit organizations, operators of public transportation services including private operators of public transportation services, local government authorities.
