

The NCDOT Integrated Mobility Division (IMD), in conjunction with RLS & Associates Inc., is pleased to offer two Drug and Alcohol Training opportunities in July.

On July 20-22, 2021 from 9:00 – 12:00 each day (you MUST attend all three days) we will be offering the **Drug and Alcohol Program Management (DAMP) and Compliance workshop.**

This three day training is geared to transit system personnel responsible for FTA drug and alcohol regulation oversight. This would be suitable for a new DAMP manager or as a refresher for a “seasoned” manager. This training covers such topics as:

- Pre-Employment Testing
- Random Testing
- Post-Accident Testing
- Drug & Alcohol Policy Compliance
- Service Agent Oversight
- Records Management
- Contractor Oversight

On July 23, 2021 we will offer the **Drug and Alcohol – Reasonable Suspicion** training. This one day training is provided for transit system employees that may be responsible for making reasonable suspicion determination. The training will be from 9:00 – 12:00. Each participant MUST have access and use their on computer in order to take the on-line exam and receive certification.

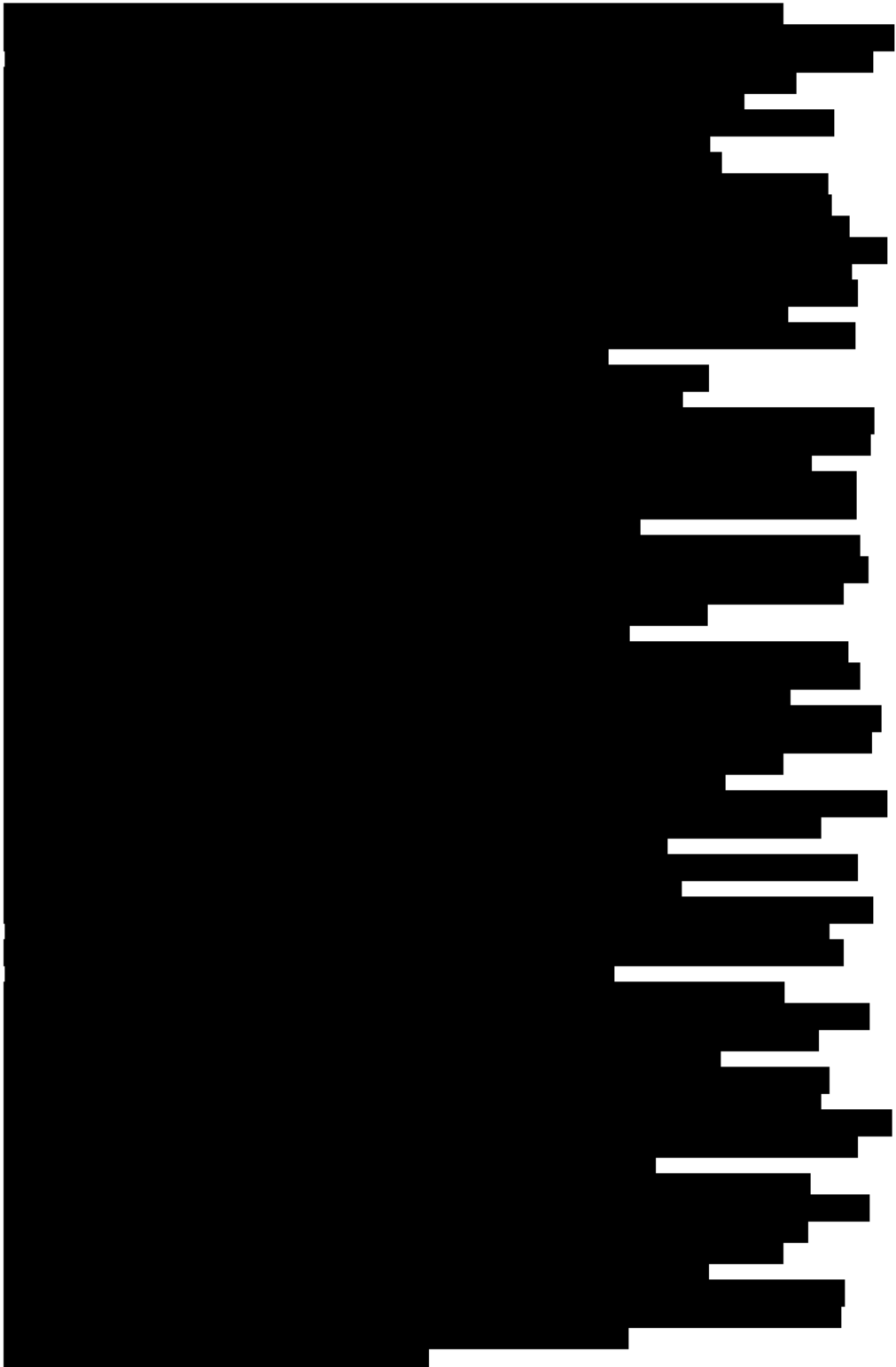
