This email is to notify you of the final due date for Capital Withdrawal forms for cancelled FY22 vehicle projects. As all of you know, the vehicle supply chain issues have hit transit particularly hard and have forced many vendors to cancel orders previously placed under NCDOT's LTV and RR Van contracts. Therefore, in order to clarify which vehicles will be removed from FY22 in order to be eligible for FY24's replacement list, **please look to submit a Capital Withdrawal form to me (attached to this email) NO LATER THAN CLOSE OF BUSINESS THIS THURSDAY 10/20/22. If you are removing vehicle VIN numbers from replacement in FY22, please note that under the withdrawal section only. If you have already submitted your Capital Withdrawal form to me for approval, please disregard this message.**
