LIGHT TRANSIT VEHICLES & RAISED ROOF VANS**

This Amendment # 1 ("Amendment") is entered by and between the North Carolina Department of Transportation and **Interstate Transportation Sales & Service, Inc.**; 1321 W. Fairfield Road; Suite 109; High Point, NC 27263 ("Vendor"), collectively known as "the Parties."

Whereas, the Parties agree that they entered into Contract 54-SBG-05062022 on April 18, 2023 for Raised Roof Vans and Light Transit Vehicles and Equipment Options. (cost not to exceed \$174,000,000.00);

Whereas on October 3, 2023, North Carolina Session Law 2023-134 became effective. As a result, a clause must be included in all contracts awarded by the Agency providing that the following entities may audit the records of the contractor during and after the term of the contract to verify accounts and data affecting fees or performance:

- The internal auditors of the affected department, agency, or institution
- The joint Legislative Commission on Governmental Operations and legislative employees whose primary responsibility is to provide professional or administrative services to the commission
