## CARES Act Phase 3

- Remaining CARES Act funding will be needs-based
- A SmartSheet survey will be distributed soon for systems to indicate additional operations and capital needs through June 30, 2021.
- An Excel tool must be completed and attached to the SmartSheet entry as supporting documentation for each request.
- You must respond to the survey and attach the completed tool to be considered for additional CARES Act funding.

# Transportation to Vaccination Sites


- New guidance allows FTA funding to be used for transportation services to COVID-19 vaccination sites.
- Through January 20, 2022, new or expanded service to provide access to vaccination sites is considered an emergency operation and eligible for 5311 or 5307 CARES and traditional apportionments at 100 percent.
- Non-shared ride service to vaccination sites is eligible as an incidental use.
