Claims Submission

- Please submit CARES Act claims monthly rather than quarterly
 - Demonstrates need for funds (one metric used for 3rd distribution of CARES Act funds)
 - Helps meet capacity of spend plan

Reminder: Claims need only be reduced by fare revenue

- This may result in a surplus in revenue as compared to expenses for the year.
- This surplus is allowable assuming that any surplus is used for transit related expenses in the future

DHHS CARES

- Initial distribution being sent out this week
 - Based on SmartSheet estimate and ROAP formula with \$2.5M allotment
- Submit supporting documentation expenses to Carolyn Freitag
 - Claim documentation can exceed what you were provided. This will enable us to justify the additional \$2.5M from DHHS
- E-mail to be sent with funding amount provided for those needing documentation for their boards
