

**Lee County** 



Lee County has worked closely with their Health Department to be able to bring their vans in a separate entrance at each clinic so there is minimal wait for their drivers and clients. That has offered them the chance to bring in additional groups later in the day from the more rural areas of the county.

To market what they are offering, they have used social media outlets, local newspaper press releases, handouts, and radio, which has worked well to let residents know free transportation to vaccines are available. Their call center also lets callers know COLTS is available to them.

They have transported clients to local physician offices and pharmacies as well. This has been very helpful in getting patients in and out to accommodate their operation.

Despite their size, COLTS has transported many residents to much needed vaccines to End COVID! In fact, they had 15 riders scheduled for today's clinic.

Chatham Transit began working with the local health department assisting with scheduling vaccination appointments for residents with transportation needs in late January 2021. By allowing CTN to schedule vaccination appointments, they were able to provide all needed rides without disruption to their normal schedule. The great partnership that they have with their local health department along with the dedication of their staff has really made this project a success in Chatham County.
