

# VACCINATION TRIPS PROVIDED BY NC TRANSIT AGENCIES



Since the beginning of the T2V efforts, 83 Transit Systems (86%) have reported over 14,899 Trips and traveled over 123,609 miles to provide transportation to 9,724 people for vaccinations.

555 Dedicated Vehicle Days have been provided.

## **System Spotlight**

#### **Wake County**

Early in 2021, GoWake partnered with the County's public health department to transport residents of group-living homes to their vaccine appointments. They proactively ensured that the County hotline asked everyone who called for an appointment if they needed transportation, so they could schedule their ride in

the same phone session as their appointment. GoWake also provided shuttle services to mass vaccine clinics to connect nearby fixed-route stops to the clinic's walk-up tent. They coordinated public transit lanes at drive-through sites, so that someone without a personal vehicle wouldn't be precluded from making an appointment at the high-volume locations. Their vans then waited during the 15-minute observation period with the passenger on board.

To date, they have provided 370 trips to/from vaccinations, serving 119 people in Wake County.

Congratulations GOWake! Great job being proactive and following through!

### **Goldsboro-Wayne Transportation Authority**

Recently highlighted on the FTA Facebook page, Goldsboro-Wayne TA "has been providing free bus rides to vaccination appointments since February. With funding from @NCDOT, to date the agency has provided more than 200 trips for residents in and outside Goldsboro, including a designated day in February to transport at-risk seniors. GWTA partnered with the Wayne County Health Department and the Goldsboro Housing Authority to provide vaccination access to both its urban and rural riders."

Since then, Goldsboro-Wayne has continued these partnerships and continued to give rides to those in need of a vaccine.

Way to go Goldsboro-Wayne!
