SINGLE TRIP PERMIT SERVICES OFFERED

There are four methods by which single trip permits may be obtained from the Central Permit Office:

- 1) **Telephone** Monday-Friday 7am-4pm
 - Call 1-888-574-6683 & press Option 1
 - A \$2.00 software fee plus a \$4.00 credit/debit card processing fee will be charged in addition to the applicable state fee for each individual single trippermit.
 - MasterCard, Visa, Discover and American Express are accepted.
 - The number of permits that may be requested in a single phone call is limited to four(4).
 - Permit requests with a vertical height in excess of 14 feet <u>cannot</u> be processed over the phone they must either be faxed in or submitted via our onlineservice.
 - Permits obtained using this method cannot be faxed to a truck stop or DOT DivisionOffice.
 - Any alteration of North Carolina issued permits is prohibited. All agency stamps must be made above or below the contents of the permit.

2) Fax – Monday-Friday 8am-5pm

- Permit applications can be found at: https://connect.ncdot.gov/business/trucking/Pages/overpermits.aspx
- Applications received by our office before 2pm are typically processed and the permits issued before closing time of the same business day.
- Please submit permit requests with a vertical height in excess of 14 feet at least two business days prior to the effective date for review and processing.
- Incomplete applications will result in the application being faxed back to the requestor and will delay issuance of the permit(s). A resend of an application for more information is not a denial of the request. The requested information should be entered on the returned application and refaxed as soon as possible to our office forprocessing.
- A \$2.00 software fee plus a \$4.00 credit/debit card processing fee will be charged in addition to the applicable state fee for each individual single trippermit.
- MasterCard, Visa, Discover and American Express are accepted.
- If payment is made using the Direct Fax Escrow Account, a \$2.00 software fee will be charged.
- Any alteration of North Carolina issued permits is prohibited. All agency stamps must be made above or below the contents of the permit.
