The Contractor will not be allowed to perform any work on the Primary and Urban Systems:  
Wilmington River Festival – Friday through Sunday (in New Hanover County only).

From November 27, 2002	Thru December 1, 2002
From April 3, 2003	Thru April 6, 2003 (New Hanover County only)
From April 18, 2003	Thru April 21, 2003
From May 23, 2003	Thru May 26, 2003
From June 27, 2003	Thru July 7, 2003
From August 29, 2003	Thru September 1, 2003
From November 26, 2003	Thru November 30, 2003

There will be no lane closures on Maps 9-14 from 6:00 a.m. 8:00 p.m. The liquidated damages are **One Thousand Dollars (\$1,000.00)** per hour, or any portion thereof.

There will be no lane closures on Maps 15 and 16 from 6:00 a.m. to 7:00 p.m. The liquidated damages are **One Thousand Dollars (\$1,000.00)** per hour, or any part thereof.

There will be no lane closures on Map 8 from 6:00 a.m. to 8:30 a.m.

**MILLING:**

Mill to the end of the radii on all intersecting streets unless otherwise directed by the Engineer.

In curb and gutter section, the gutter and drainage structures will be cleaned of milled material at the end of each day's operation.

The area to be milled in the gutter is not included in the quantity shown for the milling item. There will be no direct payment for milling in the gutter as payment for this portion of the work will be incidental to the various milling items bid.

Map 16, the Contractor will be required to mill and replace in same day's operation.

Maps 9-16, any centerline monument frame and cover, manhole and valve adjustment required will require a grout mix that reaches minimum strength requirement in sixty (60) minutes.

Map 15 and part of Map 16 where 3" milling occurs, the Contractor must mill the entire width of a roadway section in one day's operation or mill longitudinal joints on a 6:1 taper.

Notify the Engineer forty-eight (48) hours before construction will interfere with the existing Signal Loops.
