DESCRIPTION:

Furnish and install guardrail anchor units in accordance with the details in the plans, the applicable requirements of Section 862 of the Standard Specifications, and at locations shown in the plans.

MATERIALS:

The Contractor may, at his option, furnish any one of the guardrail anchor units.

Guardrail anchor unit (ET-2000) as manufactured by:

CONSTRUCTION:

Perform installation in accordance with the details in the plans and details and assembling instructions furnished by the Manufacturer.

Guardrail end delineation is required on all approach and trailing end guardrail buffer end sections for both temporary and permanent. Guardrail end delineation consists of yellow reflective sheeting applied to the entire buffer end section of the guardrail in accordance with Section 1088-3 of the Standard Specifications and is incidental to the cost of the guardrail anchor unit.

No direct payment will be made for the above described work, as such work shall be included in the contract unit price per ton for "Asphalt Concrete Surface Course, Type S9.5A".

STEEL BEAM GUARDRAIL:

Furnish and install Steel Beam Guardrail in accordance with Section 862 of the Standard Specifications.

No direct payment will be made for "Steel Beam Guardrail" as such work shall be included in the contract unit price per ton for "Asphalt Concrete Surface Course, Type S9.5A".
