The following revision has been made to the plans:

On sheet no.3, Summary of Quantities, the quantity for line item "4810000000-E-1205 Paint Pavement Marking Lines (4)" has been revised. Item numbers "4685000000-E-1205 Thermoplastic Pavement Marking Lines (4", 90 MILS)" and "4686000000-E-1205 Thermoplastic Pavement Marking Lines (4", 120 MILS)" have been added. Please void sheet no.3 in your plans and staple the revised sheet no.3 thereto.

On plan sheet TCP-1, please mark thru "Note-K." The Contractor is hereby notified that thermoplastic pavement markings will be required on the final wearing surface.

The following revisions have been made to the proposal form:
