#### **CONTRACT TIME AND LIQUIDATED DAMAGES:**

7-1-95

The date of availability for this contract is April 1, 2003.

The completion date for this contract is August 15, 2003.

The observation period for the thermoplastic pavement markings is not a part of the work to be completed by the completion date for this contract as stated above. Warrant the observation period by the payment and performance bond.

The liquidated damages for this contract are Four Hundred Dollars (\$400.00) per calendar day.

#### **INTERMEDIATE CONTRACT TIME NUMBER 1 AND LIQUIDATED DAMAGES:**

The Contractor shall complete the required work of installing, maintaining, and removing the traffic control devices for lane closures and restoring traffic to the existing traffic pattern. The Contractor shall not close or narrow a lane of traffic on **I 85** during the following time restrictions:

### DAY AND TIME RESTRICTIONS MONDAY THRU SUNDAY 6:00 A.M. TO 7:00 P.M.

In addition, the Contractor shall not narrow or close a lane of traffic on **I 85**, detain and/or alter the traffic flow on or during holidays, holiday weekends, special events, or any other time when traffic is unusually heavy, including the following schedules:

#### HOLIDAY AND HOLIDAY WEEKEND LANE CLOSURE RESTRICTIONS:

- 1. For **New Year's Day**, between the hours of 6:00 a.m. December 31st and 7:00 p.m. January 2nd. If New Year's Day is on Saturday or Sunday, then until 7:00 p.m. the following Tuesday.
- 2. For Easter, between the hours of 6:00 a.m. Thursday and 7:00 p.m. Monday.
- 3. For **Memorial Day**, between the hours of 6:00 a.m. Friday and 7:00 p.m. Tuesday.
- 4. For **Independence Day**, between the hours of 6:00 a.m. the day before Independence Day and 7:00 p.m. the day after Independence Day.

If Independence Day is on a Saturday or Sunday, then between the hours of 6:00 a.m. the Thursday before Independence Day and 7:00 p.m. the Tuesday after Independence Day.
