4. Submittals for these items may not be required. A list of pre-approved sequences is available from the producer or the Materials and Tests Unit.
5. These submittals are also reviewed by the Soils and Foundations Section. The Structure Design Unit forwards copies of the submittal to the Soils and Foundations Section.
6. The fabricator may submit these items directly to the Structure Design Unit.
7. The two sets of preliminary submittals required by Article 1072-10 of the Standard Specifications are not required for these items.

STEEL PIPE PILE

(SPECIAL)

The steel pipe piles shall be in accordance with Standard Specification 450.

Payment will be made under:

REMOVAL OF EXISTING STRUCTURE AT STATION 30+96.50 -L-

(SPECIAL)

The existing bridge is to be removed in accordance with Section 402 of the Standard Specifications. Before its removal, the existing bridge may be used as a work platform for the contractor to access building the interior bents and center span of the proposed structure. The Contractor shall assess the existing bridge and determine if modifications are needed. Any cost associated with modifying the existing bridge to serve as construction access is incidental to removal of the existing structure.
