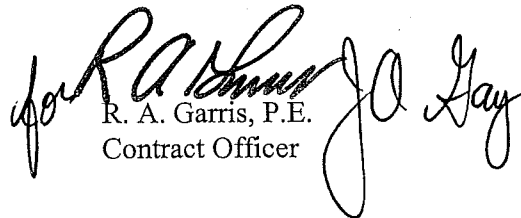
remember that work may not start before the contract has been properly executed.
