Changes to the Implementation Dates for the Work Zone Traffic Control

Qualification and Training Program

As you may know the Department is pursuing a Work Zone Traffic Control Qualification and Training Program for anyone working within the NCDOT right of way. This program is part of our compliance with the FHWA Safety & Mobility Rule (23 CFR 630 subpart j). As a result of feedback from our industry partners (mostly due to the economy and our desire not to implement a timeline that we know some will not be able to meet), the NCDOT has postponed the implementation dates of the program one year. The new implementation dates are as follows:

Flagger Qualifications and Training - July 1, 2010 Installer Qualifications and Training - January 1, 2011 Supervisor Qualifications and Training - July 1, 2011

In the next year, the Department will reconsider the on the job training (OJT) requirement for flaggers as we have gotten strong feedback that most small companies and municipalities will not be able to obtain the present requirement of 40 hours of OJT. We plan to investigate the common practice of other State DOT's and intend for our program to be similar to those OJT requirements. We expect our industry partners to take advantage of this implementation delay by continuing to pursue courses and OJT to meet the requirements of the program by the revised dates.

Please do not misunderstand our implementation delays. The NCDOT fully supports the implementation of the Work Zone Qualifications and Training requirements and is committed to seeing this program come to fruition. Working together with the industry we have already made great progress and look forward to seeing our work zones become even safer for the workers and traveling public.

We will continue to work with our industry partners through our Work Zone Qualification and Training Committee meetings and address all the issues that remain in the coming year. Additional information can be found on our web site at:

and 2006 Metric Roadway Standard Drawings

In 1999, the North Carolina Department of Transportation elected to return to the English measurement system when developing project plans as a result of the elimination of the FHWA metric requirement in the 1998 TEA 21 legislation. However, design efforts had already begun on approximately sixty projects utilizing the metric measurement system. Of those, some remained metric and were let under the 2002 Specifications and Standards, and some were re-engineered (converted) to English plans. Currently, there are fourteen projects that will be designed, let and constructed utilizing the 2006 Metric Specifications and Standards. See attached list for project information and tentative let dates.

The Metric Specifications Book is a mirror image of the 2006 (English) Specifications Book, except for the conversion to metric units and dimensions. The 2006 Metric Standard Drawings is a mirror image of the 2006 (English) Standard Drawings, except that Standards 840.25 and 700.01 have been updated to match Details 840D25 and 700D01. The Specifications and Standards are available in .pdf on the Projects Services Website at: http://www.ncdot.org/doh/preconstruct/ps/contracts/default.html

The 2006 Metric Specifications and Standards are being printed within the Department and are available for purchase. Due to the small number of metric projects to be let over the next several years, a limited number will be printed. Therefore we ask that you review the attached list of projects and not order immediately if projects of interest to you are further out in the future. This will allow us to manage the printing demands much more efficiently. The 2006 Metric Standard Specifications for Roads and Structures and the 2006 Metric Roadway Standard Drawings are \$25.00 each plus 6.75% North Carolina sales tax. Change to FHWA - 1273 concerning Social Security Numbers and

Addresses on Weekly Payroll Submissions

Beginning with the February 17, 2009 letting, the Project Special Provision entitled Revision to FHWA-1273 Concerning Personal Information on Payroll Submissions will be effective.

On January 18, 2009, the final rule for 29 CFR Parts 3 and 5 became effective. It requires the contractor to use only the last four digits of a worker's social security number and no address on the Weekly Payroll Submission, thus protecting the worker's privacy.

This provision will be used on all Federal Projects.

Revise the Standard Special Provision FHWA-1273 Required Contract Provisions Federal-Aid Construction Contracts as follows:

Section V, Paragraph 2b is replaced with the following:

The payroll records shall contain the name, and the last four digits of the social security number of each such employee, his or her correct classification; hourly rates of wages paid (including rates of contributions or costs anticipated for bona fide fringe benefits or cash equivalent thereof the types described in Section 1(b)(2)(B) of the Davis Bacon Act); daily and weekly number of hours worked; deductions made; and actual wages paid.

<u>LIABILITY INSURANCE</u>: (11-18-08)

Page 1-68, Article 107-16 is amended to include the following as the first, second, third and fourth paragraphs:

The Contractor shall be liable for any losses resulting from a breach of the terms of this contract. The Contractor shall be liable for any losses due to the negligence or willful misconduct of its agents, assigns and employees including any sub-contractors which causes damage to others for which the Department is found liable under the Torts Claims Act, or in the General Courts of Justice, provided the Department provides prompt notice to the Contractor and that the Contractor has an opportunity to defend against such claims. The Contractor shall not be responsible for punitive damages.

The Contractor shall at its sole cost and expense obtain and furnish to the Department an original standard ACORD form certificate of insurance evidencing commercial general liability with a limit for bodily injury and property damage in the amount of \$5,000,000.00 per occurrence and general aggregate, covering the Contractor from claims or damages for bodily injury, personal injury, or for property damages which may arise from operating under the contract by the employees and agents of the Contractor. The required limit of insurance may be obtained by a single general liability policy or the combination of a general liability and excess liability or umbrella policy. The State of North Carolina shall be named as an additional insured on this commercial general liability policy. The policy may contain the following language as relates to the State as an additional insured: "This insurance with respect to the additional insured applies only to the extent that the additional insured is held liable for your or your agent's acts or omissions arising out of and in the course of operations performed for the additional insured."

The Contractor shall maintain all legally required insurance coverage, including without limitation, worker's compensation and vehicle liability, in the amounts required by law. Providing and maintaining adequate insurance coverage is a material obligation of the contractor and is of the essence of this contract. All such insurance shall meet all laws of the State of North Carolina. Such insurance coverage shall be obtained from companies that are authorized to provide such coverage and that are authorized by the Commissioner of Insurance to do business in North Carolina. The Contractor shall at all times comply with the terms of such insurance policies.

Upon execution of the contract, provide evidence of the above insurance requirements to the Engineer.
