As soon as possible following receipt of the properly executed contract bonds, the Department will complete the execution of the contract and return one copy of the contract to you. Please remember that **work may not start before the contract has been properly executed.**

I wish to call your attention to the project Special Provision titled "Notice to Proceed" beginning on page one of the RFP. Execution of the contract by the Department will constitute Notice to Proceed for preconstruction activities only, as authorized in the amount of \$17 Million. In accordance with the Record of Decision, the FHWA will not concur in the issuance of a Notice to Proceed with construction, nor will Federal funds be authorized for construction until the necessary permits are issued. At such time, the Department will solicit authorization for construction funding and issue a written Notice to Proceed for all construction activities.

In addition, I wish to call your attention to Articles 107-16, 108-1, 108-2, and 108-3 of our *Standard Specifications* relative to liability insurance, prosecution of work, progress schedule, and preconstruction conferences. Information regarding these items and other items is available at <http://www.NCDOT.org/business> under the Project Letting link and should be addressed prior to beginning work. Please forward this information to the Division Engineer **Jerry Jennings, PE**, or Division Construction Engineer, **Robert E Capehart, PE**, as soon as possible so that a preconstruction conference can be held. In accordance with Article 104-2 of our *Standard Specifications*, it will be necessary for you to submit the name of those individuals within your organization who will be authorized to sign supplemental agreements that may be necessary in the performance of the work under this contract.
