see a live demonstration of the AV shuttles along the rural route and view the simulator. This is expected to take place in February 2023.

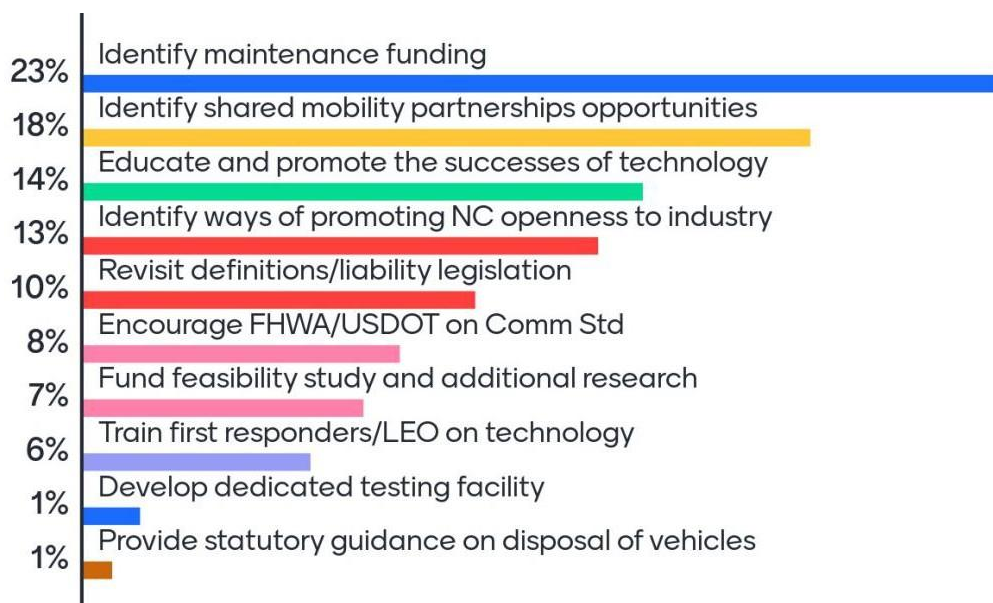
FAV Committee Strategic Planning

The FAV Committee brainstormed the near-term investments that could be made to advance FAV in the state of North Carolina. The Committee identified people that could be responsible for advancing certain components of FAV. A summary of the discussion is provided below.

Where do you think NC should invest its resources (time, money, ventures, etc.) in the next 18 months – 2 years?

- Identify maintenance funding
- Encourage FHWA/USDOT on communication standards
- Revisit definitions and liability legislation
- Identify shared mobility partnership opportunities
- Educate and promote the successes of technology
- Train first responders/law enforcement officers on technology
- Provide statutory guidance on disposal of vehicles
- Develop dedicated testing facility
- Fund feasibility study and additional research
- Identify ways of promoting North Carolina's openness to industry
