

**Traffic Records Coordinating Committee Meeting Minutes**  
**August 20, 2003**  
**UNC HSRC 3<sup>rd</sup> Floor Conference Room**

Began meeting at 9:40 AM.

**Welcome:**

Kevin Lacy welcomed everyone and thanked everyone for coming to the meeting. He asked for any comments or suggestions on the proposed mission statement. It was accepted as is. Kevin brought the committee up to date on the national survey being completed by Tony Ku. The NHTSA Traffic Records Systems Survey Inventory was passed out to the committee members. He mentioned they were still waiting on feedback from the NC Department of Justice Administrative Office of the Court contact. Tony plans to finish the NHTSA survey and publish it on our web site by September 30, 2003. At this point, everyone should have a copy of forms (handed out in the last meeting). If you did not receive a copy and/or you need an electronic copy form, please contact Tony W. Ku at 919-715-3128. If you see any questionable data and/or incomplete portion in your expertise area, please make correction and/or help to finish up the incomplete portion send to Tony W. Ku by September 15, 2003. Tony Ku offers his sincerest thanks to everyone who helped him fill out the NHTSA survey.

Kevin opened the discussion with the remarks about the background and history of the Executive Committee for Highway Safety (EC4HS) and introduced the presentation to come. Key members included former chair Gene Conti, Kevin Lacy, the NC Chief Highway Engineer, the NC Chief Design Engineer, David King (in the Transit & Pedestrian area), John Sullivan (FHWA), George Tatum (DMV), Doug Robertson (HSRC), Don Nail (NC DOT GHSP), Jim Long (DOI), Colonel of the NC SHP, and city representatives from Jacksonville and Mooresville among others. As part of their first meeting, the committee adopted the AASHTO key emphasis areas as North Carolina's. Brad Hibbs added that not all states have the structure to set up 2 committees which can address the needs and issues of their state the way North Carolina can. NC, Washington State, Iowa, and Pennsylvania have been leaders in this area.

LC Smith provided an update of the GIS work currently underway. He stated that some components of the LRS are now functional. The Linear Referencing System (LRS) will support additional internal GIS Unit processes by October 1st. Additional functionality and support to other agencies will be accomplished incrementally. Rosa indicated there was no new progress on the Ecrash.

(Susan Dyson provided a copy of her presentation slides describing the North Carolina Hospital Inpatient Discharge Database).

**Keynote Presentation from Cliff Braam**

Cliff Braam presented an overview presentation of the North Carolina Crash Data and Initiatives as related to the 22 key emphasis areas as described in the AASHTO plan. His presentation was the same as the one given to the EC4HS. Cliff went through each of the 22 key areas, shared the current data, and pointed interesting results in the NC numbers. Cliff mentioned that the EC4HS will soon try to prioritize these 22 issues so that NC can begin addressing them in a timely and productive fashion. (Cliff passed out a handout with the data summaries and copies of his slides).

Key Focus Points in his list:

- 1) Graduated Licensing for Young Drivers
- 2) Ensuring Drivers are licensed & competent
- 3) Older Drivers
- 4) Aggressive Drivers
- 5) Impaired Driving
- 6) Alert/Distracted Drivers

- 7) Driver Safety Awareness
- 8) Seat Belt Use
- 9) Pedestrian Safety
- 10) Bicycle Safety
- 11) Motorcycle Safety
- 12) Truck Safety
- 13) Vehicle Safety (Not a feasible concern for NC)
- 14) Vehicle/Train Safety
- 15) Vehicle On Road Safety
- 16) Vehicle Off Road Safety
- 17) Intersection Safety
- 18) Head-on and Median Safety
- 19) Work Zone Safety
- 20) EMS Safety
- 21) Information Systems Improvements (TRCC concern)
- 22) Safety Process and Management Improvements (TRCC concern)

Doug Robertson added that these goals were a starting point and that there were other areas which would possibly be included. Ron Hughes commented that the TRCC group should be aware of the losing sight of the purpose by getting caught up in political goals or clichés. His example was the one from education, “No child left behind!” The group noted that any effort would require political support in order to succeed. Kevin noted that “measurable” goals need to be set – that way efforts can be measured, evaluate, and hopefully achieved. An example was the efforts in the Railroad Crossing efforts which have shown a positive trend.

Timely data access was mentioned by Ron Hughes and reiterated by Todd Hatley.

The question of city/local traffic exposure was raised – current data is mostly limited to gas tax revenues and Interstate, US, NC and arterial roads where DOT collects ADTs. LC Smith added that he would like to present the committee with an NCDOT-GIS proposal for a research project to enable better estimation of traffic on local streets, and to seek TRCC comments and support. He agreed to send the committee a copy to be reviewed.

The question of city/local exposure was raised – current data is mostly limited to gas tax revenues and Interstate, US, NC and arterial roads where DOT collects ADTs. LC Smith added that he would like to present the committee with a NC GIS proposal for their comments and possibly their support. He agreed to send the committee a copy to be reviewed.

It was noted that partnerships need to be formed and nurtured. Law enforcement, district attorneys, local government officials all need to be working together to identify the problems and work to implement solutions. Input and linkages as noted the month before are important.

The discussion was interrupted and the meeting was adjourned at 11:40 PM.
