CFTF BACKGROUND

Study commission created in 1991 by state statute

The "policy arm" of the State's Child Fatality Prevention System


35 Total Members: experts, state & local government representatives & legislators

46% decrease in child death rate since CFTF & CFP system creation

CHARGE OF STATE CHILD FATALITY PREVENTION SYSTEM [VIA ARTICLE 14 OF NC JUVENILE CODE]

- ▶ Develop a communitywide approach to child abuse and neglect;
- ▶ Study and understand causes of childhood death;
- ► Identify gaps in service delivery in systems designed to prevent abuse, neglect, and death; and
- Make and implement recommendations for laws, rules, and policies that will support the safe and healthy development of our children and prevent future child abuse, neglect, and death.

THREE COMPONENTS TO NC CHILD FATALITY PREVENTION SYSTEM



TASK FORCE RESPONSIBILITIES

- ▶ Studies, analyzes, and reports on causes and data related to child deaths
- ► Receives and considers reports from State Child Fatality Prevention Team
- Performs studies and evaluations as needed in order to carry out its mandate
- Annually reports to the Governor and General Assembly with recommendations for changes to any law, rule, or policy to prevent child death and maltreatment and promote the safety and well-being of children

TASK FORCE PROCESS COMPONENTS

- ▶ Public meetings between legislative sessions
 - \triangleright Full Task Force meetings (3-4)
 - ► Committee meetings (2 4)
- Proposed issues for review may come from Local and State Teams, issue application process, trends identified by data
- ► Stakeholder or study groups may be convened to address or examine in-depth a particular issue
- Ongoing information sharing and collaboration among experts and community partners

CFTF ACCOMPLISHMENTS: A FEW HIGHLIGHTS AMONG MANY ...

- Graduated Driver License Program & various teen driver safety measures
- Child passenger safety laws, school bus safety laws
- Measures to combat opioid epidemic (improved CSRS, access to overdose reversal drug, safe disposal)
- ► Infant Safe Surrender Law
- Pulse Oximetry Newborn Screening (for certain congenital heart conditions)

- Strengthened Sex Offender Registry
- Laws addressing smoke alarms & CO detectors
- Law requiring child-proofing and labeling for E-cig nicotine liquid containers
- ► Safe Sleep awareness
- Support for programs providing child maltreatment prevention, diagnosis, and treatment



CFTF & TEEN DRIVER SAFETY

- ► Zero tolerance for underage drinkers who drive (1995)
- ► Graduated Driver's License
 - Enacted in 1997; second in nation
 - Strengthened in 2011
- ► Under 18 prohibited from using mobile phone while driving (2006)
- Ongoing monitoring of GDL and Driver Education

CFTF & CHILD PASSENGER SAFETY

- Required restraints for under 12; safety seats for under 4 (1994)
- Two-point penalty for failure to properly restrain child (2000)
- ► Booster seat law requiring child under 8 and under 80 pounds to be in a booster seat (2004)
- Removal of child safety seat exemption for attending to child (2007)
- Limiting liability for child passenger safety technicians (2008)

CFTF & IMPAIRED DRIVING LAWS

- Makes presence of a child in vehicle a grossly aggravating factor for purposes of sentencing for DWI (1993)
- ► Zero tolerance for underage drinkers (1995; also related to teen drivers)
- Increase driver's license restoration fee to go to Forensics Test for Alcohol for impaired driving programs (2010)
- ▶ Penalty increased for driving impaired with a child in the car (2011)

CFTF & SCHOOL BUS AND SCHOOL ZONE SAFETY

- ► CFTF charged by legislature to study issues relating to requiring restraints in school buses (2007)
- ► Nicholas Adkins School Bus Safety Act (2009)
 - ► Allows pictures of stop arm violation as acceptable evidence for conviction
 - Makes it a felony if a student is killed due to illegal pass of stopped school bus
- ▶ Increased fine for speeding in a school zone (2011)
- ► A law authorizing civil penalties for passing a stopped school bus and the utilization of school bus cameras to facilitate automatic enforcement (2017, S.L. 2017-188; bill summary available at:

CFTF & VARIOUS OTHER HIGHWAY SAFETY LAWS

- Child Bicycle Safety Act required bicycle riders age 15 and younger to wear an approved helmet when riding on public roads and rights-of-way. (2001)
- All-Terrain Vehicle Safety Law set a minimum age of 8 for operating an ATV and put various other requirements in place to increase ATV safety, including adult supervision. (2005)
- Law requiring the use of rear seat safety belts for all passengers. (2006)
- ► Raising the age for those permitted to ride in open truck beds to 16, and removal of exemption for small counties (2008)

ON THE HORIZON FOR 2017-18

All CFTF recommendations for the 2018 Action Agenda must be approved by the full CFTF, finalized by March, 2018.

Related to highway safety, 2017-18 CFTF meetings will address:

- ▶ Primary enforcement of rear seat restraints: HB 672 introduced in 2017, still eligible in short session
- Impaired driving prevention related to ignition interlocks for all DWI offenders (endorsed on CFTF 2017 agenda; no legislation introduced)
- ▶ Updates on highway safety issues or legislation as needed

PRIMARY ENFORCEMENT OF REAR SEAT RESTRAINTS

Currently, failure to wear a seat belt in the back seat by those 16 and up is not justification for a traffic stop. MV crashes are leading cause of death for NC teens age 15 to 17

- Primary enforcement leads to higher usage rates, and seat belt use is the most effective way to prevent fatalities and injuries in the event of a crash
- ▶ From 2009 to 2013, an average of 52% of teen motor vehicle fatalities in the U.S. were to kids not buckled up
- ► Odds of driver death in the presence of unrestrained rear seat occupants are more than double than when rear seat occupants are restrained
- Estimates are that this change in law would result in reduced MV fatalities in NC that could yield an economic savings of \$100 million annually

IGNITION INTERLOCKS FOR ALL DWI OFFENDERS

Current NC law makes ignition interlocks mandatory only with a BAC greater than .15 or for subsequent offenders

- Estimates are that the average drunk driver has driven drunk over 80 times prior to first DWI arrest
- ▶ Of traffic deaths in the U.S. to children age 0 to 14 in 2014, 19% involved an alcoholimpaired driver; alcohol is involved in one-third of all fatal crashes in NC
- ► CDC recommends ignition interlocks to prevent repeat DWI offenses, and mandated use of interlocks for all DWI offenders, including first offenders
- ▶ Half of all states require ignition interlocks for all offenders, but not NC

DATA, EXPERTISE & COLLECTIVE WISDOM IS KEY ...
