Installation access requirements. The Contractor shall contact USAG-FB as needed for access and shall follow USAG-FB Installation access requirements.

The contractor shall always maintain access to ATF Road during the project. Construction on Map 1 King Road shall be phased to always allow access to ATF Road on the existing pavement or the final surface course.

Existing utilities remain in place and have not been relocated for the project. Contractor shall coordinate with Fort Liberty utility staff to have existing utilities located before beginning any excavation or construction.

Contractor shall resurface to radius return on all side streets to the mainline on each map and as directed by the Engineer.

The pre-bid conference will include a thorough discussion of the plans, contract pay items, special provisions, etc. Only bidders who have attended and properly registered at the above scheduled pre-bid conference and who have met all other prequalification requirements will be considered prequalified to bid on this project. A bid received from a bidder who has not attended

and properly registered at the above scheduled pre-bid conference will not be accepted and considered for award.

Attendance at the pre-bid conference will not meet the requirements of proper registration unless the individual attending has registered at the pre-bid conference in accordance with the following:

- (A) The individual has signed his name on the official roster no later than thirty (30) minutes after the above noted time for the beginning of the conference.
 - The Division staff will take the name, company, e-mail address and phone number of the individual's attending remotely. The names and their company name should be read aloud, and the meeting recorded.
- (B) The individual has written in the name and address of the company he or she represents.
- (C) Only one company has been shown as being represented by the individual attending.
- (D) The individual attending is an officer or permanent employee of the company they are representing.

Attendance at any prior pre-bid conference will not meet the requirement of this provision.
