General:

The following utility companies have facilities that will be in conflict with the construction of this project:

- A) Charter Communications
- B) Brightspeed Communications
- C) Cape Hatteras Electric Cooperative Power (Distribution)

The conflicting facilities of these concerns will be adjusted prior to the date of availability, unless otherwise noted and are therefore listed in these special provisions for the benefit of the Contractor. All utility work listed herein will be done by the utility owners. All utilities are shown on the plans from the best available information.

The Contractor's attention is directed to Article 105-8 of the Standard Specifications.

Utilities Requiring Adjustment:

Utility relocations are shown on the Utilities by Others Plans.

- C) Cape Hatteras Electric Cooperative Power (Distribution)
 - 1) Cape Hatteras Electric Cooperative will install new utility poles and hang existing aerial line to new utility poles as well as existing utility poles to remain as indicated in the plans within the project limits prior to the date of availability.
 - 2) Cape Hatteras Electric will deenergize the electric lines in the span adjacent to the bridge and the next sequential span each direction for the duration of the bridge construction. Cape Hatteras Electric Cooperative requires a 2 week notice by the contractor to deenergize the aerial lines.
