#### **NOTES TO CONTRACTOR:**

- \*All equipment shall be cleaned/washed before entry to the conservation easement area or the Broad River and prior to any reentry after leaving the site.
- \*Areas of disturbance shall be revegetated using plants native to western North Carolina. Use of seed mixes shall contain only native plants with the exception that native seed mixes may be combined with non-invasive temporary cover species such as rye grain, or winter wheat. Intentional use of invasive species such as lespedeza or fescue will be considered a violation of the conservation easement.
- \*All soil, rock or other materials shall be removed from the conservation easement area upon successful completion of the project. This includes all materials used in constructing a causeway within or adjacent to the Broad River. Streambanks shall be returned to a condition that closely mimics natural conditions to the extent practicable.
- \*All silt fencing or similar construction materials shall be removed from the conservation easement promptly upon successful completion of the project.
