GENERAL

HAUL ROADS:

Revise the *Standard Specifications* as follows:

Page 1-45, Article 105-15 RESTRICTION OF LOAD LIMITS, line 31, add the following after second sentence of the second paragraph:

At least 30 days prior to use, the Contractor shall notify the Engineer of any public road proposed for use as a haul road for the project.

CONTRACT TIME AND LIQUIDATED DAMAGES:

SP1 G08 A

The date of availability for this contract is October 27, 2025 for -L- Sta. 10+00 (+/-) to -L- Sta. 12+00 (+/-) and -Y- (US 64), except December 1, 2025 for the remainder of the project, except that work in jurisdictional waters and wetlands shall not begin until a meeting between the DOT, Regulatory Agencies, and the Contractor is held as stipulated in the permits contained elsewhere in this proposal. This delay in availability has been considered in determining the contract time for this project.

The completion date for this contract is **January 28, 2029**.

Except where otherwise provided by the contract, observation periods required by the contract will not be a part of the work to be completed by the completion date and/or intermediate contract times stated in the contract. The acceptable completion of the observation periods that extend beyond the final completion date shall be a part of the work covered by the performance and payment bonds.

The liquidated damages for this contract are **Two Hundred Dollars** (\$ 200.00) per calendar day. These liquidated damages will not be cumulative with any liquidated damages which may become chargeable under Intermediate Contract Time Number 1.

INTERMEDIATE CONTRACT TIME NUMBER 1 AND LIQUIDATED DAMAGES: (7-1-95) (Rev. 2-21-12)

Except for that work required under the Project Special Provisions entitled Planting, Reforestation and/or Permanent Vegetation Establishment, included elsewhere in this proposal, the Contractor will be required to complete all work included in this contract and shall place and maintain traffic on same.

The date of availability for this intermediate contract time is October 27, 2025 for -L- Sta. 10+00 (+/-) to -L- Sta. 12+00 (+/-) and -Y- (US 64), except December 1, 2025 for the remainder of the project.

The completion date for this intermediate contract time is August 1, 2028.

The liquidated damages for this intermediate contract time are Two Thousand Four Hundred **Dollars (\$ 2,400.00)** per calendar day.
