Maps #2 and/or #3: Western Boulevard to End of Resurfacing Limits

Monday thru Sunday, 6:00 a.m. to 9:00 p.m.

Maps #4 thru #8

Monday thru Friday, 6:00 a.m. to 9:00 a.m. and 4:00 p.m. to 7:00 p.m.

In addition, the Contractor shall not close or narrow a lane of traffic on **Any Map**, detain and/or alter the traffic flow on or during holidays, holiday weekends, special events, or any other time when traffic is unusually heavy, including the following schedules:

HOLIDAY AND HOLIDAY WEEKEND LANE CLOSURE RESTRICTIONS

1. For **unexpected occurrence** that creates unusually high traffic volumes, as directed by the Engineer.
2. For **New Year's Day**, between the hours of **6:00 a.m.** December 31st and **7:00 p.m.** January 2nd. If New Year's Day is on a Friday, Saturday, Sunday or Monday, then until **7:00 p.m.** the following Tuesday.
3. For **Easter**, between the hours of **6:00 a.m.** Thursday and **7:00 p.m.** Monday.
4. For **Memorial Day**, between the hours of **6:00 a.m.** Friday and **7:00 p.m.** Tuesday.
5. For **Independence Day**, between the hours of **6:00 a.m.** the day before Independence Day and **7:00 p.m.** the day after Independence Day.

If **Independence Day** is on a Friday, Saturday, Sunday or Monday, then between the hours of **6:00 a.m.** the Thursday before Independence Day and **7:00 p.m.** the Tuesday after Independence Day.

6. For **Labor Day**, between the hours of **6:00 a.m.** Friday and **7:00 p.m.** Tuesday.
7. For **Thanksgiving**, between the hours of **6:00 a.m.** Tuesday and **7:00 p.m.** Monday.
8. For **Christmas**, between the hours of **6:00 a.m.** the Friday before the week of Christmas Day and **7:00 p.m.** the following Tuesday after the week of Christmas Day.
9. For **the following events**, occurring in **Raleigh**, between the hours of **7:00 a.m.** and **11:59 p.m.** each day the event is open to the public: **St. Patrick's Day Parade, Dreamville, Artsplasure, Raleigh International Food Festival, Raleigh Pride, July 4th Fireworks, African American Cultural Festival, Hopscotch Music Festival, Bluegrass Festival, NC Veterans Parade, and/or First Night of Lights.** These events only apply to **Maps #2 and/or #3.**
10. For **any event**, occurring at **the following locations** between **three (3)** hours before the start and **two (2)** hours after the end of the event: **Red Hat Amphitheater, Duke Energy Center for Performing Arts, and/or Raleigh Convention Center.** These events only apply to **Maps #2 and/or #3.**

Holidays and holiday weekends shall include New Year's, Easter, Memorial Day, Independence Day, Labor Day, Thanksgiving, and Christmas. The Contractor shall schedule his work so that lane closures will not be required during these periods, unless otherwise directed by the Engineer.

The time of availability for this intermediate contract work shall be the time the Contractor begins to install all traffic control devices for lane closures according to the time restrictions listed herein.

The completion time for this intermediate contract work shall be the time the Contractor is required to complete the removal of all traffic control devices for lane closures according to the time restrictions stated above and place traffic in the existing traffic pattern.

The liquidated damages are **Two Hundred Fifty Dollars (\$ 250.00)** per fifteen (15) minute time period.

The liquidated damages are **Five Hundred Dollars (\$ 500.00)** per fifteen (15) minute time period.

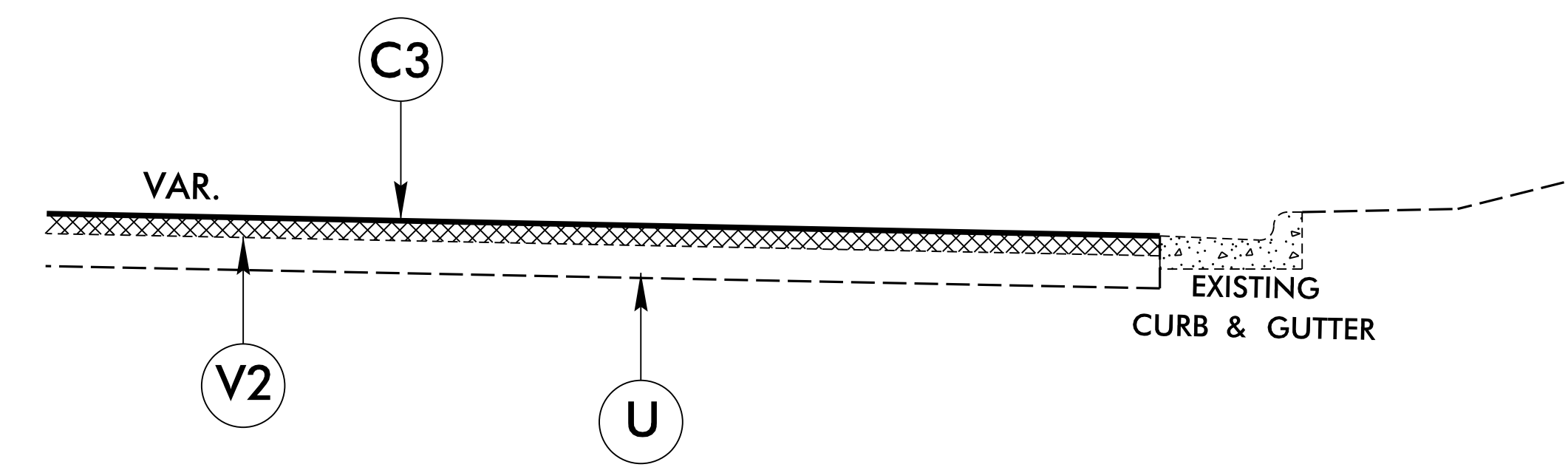

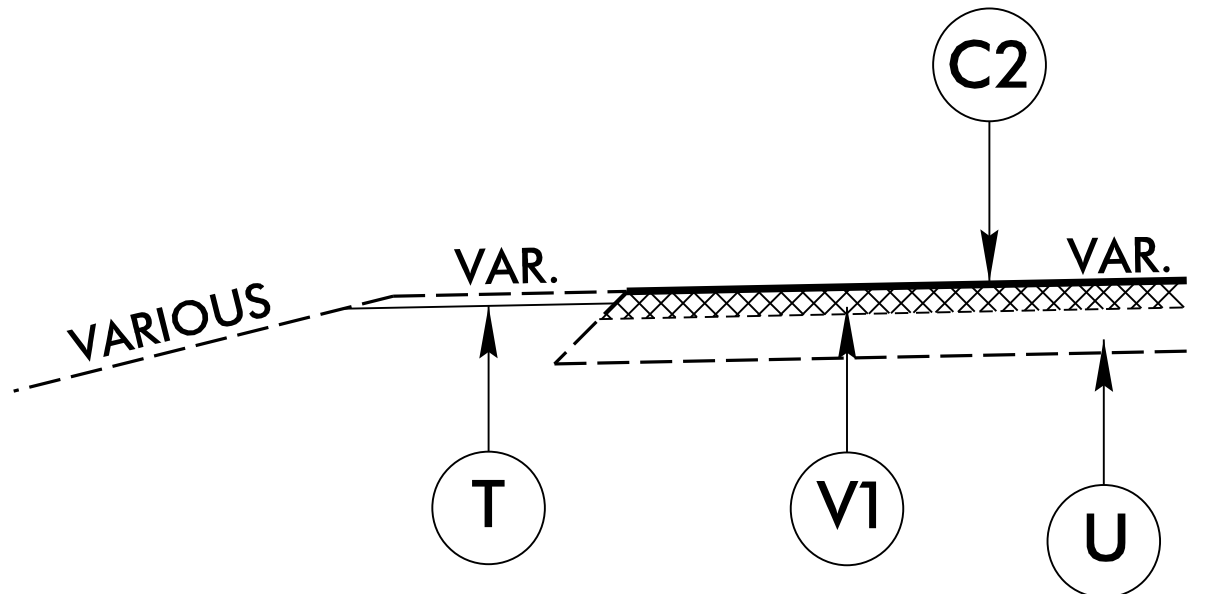

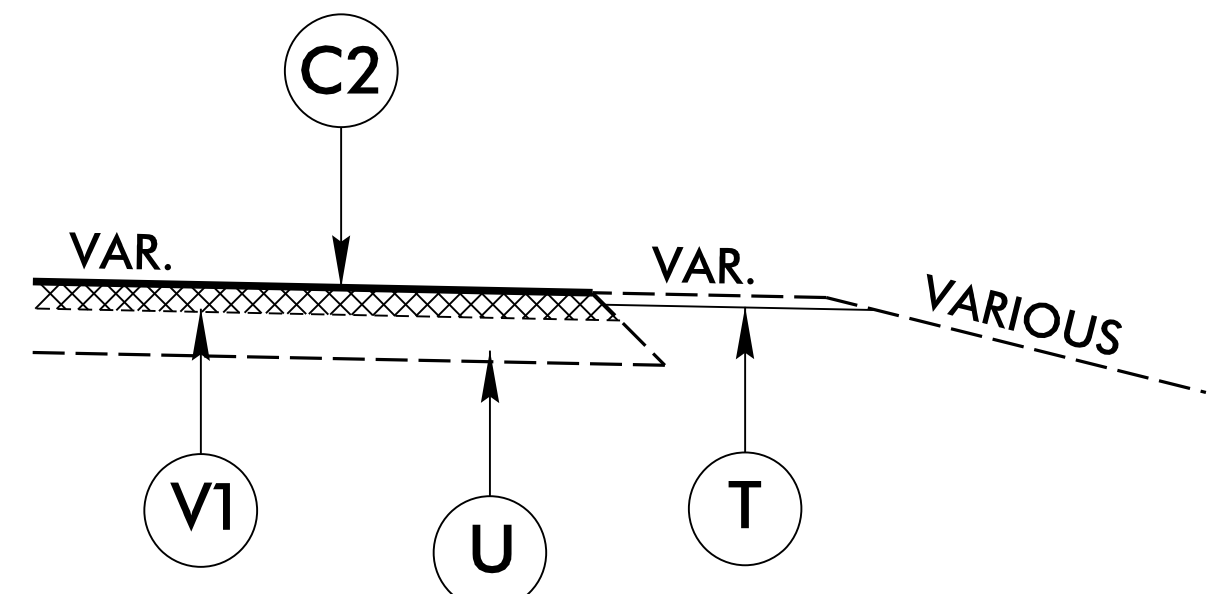
