Dates for highlighted activities are critical and must be met in order to reach the January 6, 2005 award date.

OVERVIEW

The project will be a 4-lane freeway on new location with a variable 36' to a 46' median. There will be interchanges at each end, overpasses, service roads and -Y- line realignments. A portion of the project will be widening existing US 13 with at-grade intersections and partial control of access.

Project services shall include but are not limited to:

- Design Services right of way and construction plans
- Construction Services necessary to build and ensure workmanship of the designed facility.
- Permit Preparation/Application
- Right of Way Acquisition.

The State FEIS was approved August 29, 2003. The State ROD is expected in June 2004.

The ICE Analysis will be completed by the Department to be included in the Design Build Team's permit application.

MANDATORY PERMIT MEETING: PREQUALIFICATION TO SUBMIT SOQ'S

Because of the nature of the permit work, and in order to give prospective proposers the opportunity to gain a thorough understanding of the permit expectations, all prospective proposers shall attend a mandatory permit meeting at the NCDOT Highway Building Auditorium, 1 S. Wilmington Street, in Raleigh. The meeting will begin promptly at 10:00am and conclude at approximately 12:00 Noon. Doors will be open at 9:00am to facilitate registration.

The permit meeting will include a thorough discussion of the permit application process.

Only proposers who have attended and properly registered at the above scheduled permit meeting will be considered prequalified to submit an SOQ on this project. An SOQ received from a proposer who has not attended and properly registered at the above scheduled permit meeting will not be considered for shortlisting.

Attendance at the permit meeting will not meet the requirements of proper registration unless the individual attending has registered at the permit meeting in accordance with the following:

- 1. The individuals representing the Prime Contractor, lead consultant, and the Environmental Permit Specialist, and the Quality Manager must sign the official roster no later than fifteen (15) minutes after the scheduled start time of the meeting.
- 2. The individual has written the name, address, and email address of the company/Design Build Team he or she represents.
- 3. Only one company/Design Build Team has been shown as being represented by the individual attending.
- 4. The individual attending is an officer or permanent employee of the company or Design Build Team they will be representing. Individuals attending this meeting shall be those persons who will be personally involved in the day to day activities of this project.

Attendance at any prior permit meeting will not meet the requirement of this provision.
