
In accordance with the policy memo entitled "Bonding Requirements for Division Let Projects" from T. R. Gibson, PE, Chief Engineer dated October 18, 2012, all bridge replacement and major bridge rehabilitation contracts now require 100% payment and performance bonds if the bid amount exceeds \$300,000.

**Statement of Minority Business Enterprise & Women Business Enterprise participation must be presented with the bids.**
