All parts and materials not listed above and required to complete the full scope of work are the sole responsibility of the Contractor to furnish. For requirements of working drawings submittal, see the other special provisions.

The Contractor shall specifically note that no parts are being provided for repositioning of the rack, wedge guide adjustment, coupler maintenance, or joint replacement.

# **Delivery and Acceptance of Center Bearing Assembly**

The parts listed above have been purchased by the Department and will be delivered to the project site at the request of the Contractor. The Contractor shall notify the Engineer in order to request delivery and allow no less than 2 business days for delivery. At the time of delivery the Contractor and the Engineer will approve the condition of the parts and the Contractor will take sole possession and sole responsibility for all parts until project completion and acceptance. Any damage that occurs following Contractor acceptance and prior to project completion will be the sole responsibility of the Contractor.

## **Measurement and Payment**

There will be no measurement or direct payment for delivery and acceptance of the Department Supplied Parts. Associated costs shall be included in the prices bid for the various other items of work.
