A1.0 	Clarification of Demolition Key Notes D-10 and D-11 which overlap on Sheet A1.0: "D-10: In Men 106 & Women 107, Contractor to remove tile and wall sheathing on South and West walls when Architect is present on site. Minimum one week notification of date of demolition to be given. The existing tile has a horizontal stress fracture along the entire wall and the stress fracture must be evaluated."

		Architect/Owner of resulting condition- if floor slab one level or if it is
		recessed."

- 4. A2.4 Toilet Accessory Schedule: Add Item 13: Round Rubber Bumper. Install. on outside of each door into Handicap Accessible Stalls, field verify height to align with wall counter.
- 5. A2.4 Elevations 2, 4, 5, 7 & 9: Mount toilet paper holders at minimum 24" AFF-. to max. 48" AFF at roll dispenser rod, maintain clearance at grab bar.
- 6. A3.1 Add detail 11/A3.1 for installing 2 new Prefabricated Wood Louvers and . Frame Units with insect screens. Paint to match trim. They replace the . existing wood louvers and the wood boxes currently covering them at . each gable end. Size estimate 10'-0" at base and 2'-0" High at peak. Size to be confirmed when existing box cover removed.
- Add note: Provide new devices and stainless steel cover plates at original 7. E1 device locations.


