Bids must be submitted on the official bid sheet included in the proposal. The following statement must be prominently displayed on the front of the envelope:

The North Carolina Department of Transportation, in accordance with the provision of Title VI of the Civil Rights Act of 1964 (78 Stat. 252) and the Regulations of the Department of Transportation (49 C.F.R., Part 21), issued pursuant to such act, hereby notifies all bidders that it will affirmatively insure that the contract entered into pursuant to this notice will be awarded to the lowest responsible bidder without discrimination on the grounds of sex, race, color, or national origin.

In accordance with the policy memo entitled "Bonding Requirements for Division Let Projects" from T. R. Gibson, PE, Chief Engineer dated October 18, 2012, all bridge replacement and major bridge rehabilitation contracts now require 100% payment and performance bonds if the bid amount exceeds \$300,000.

Statement of Minority Business Enterprise & Women Business Enterprise participation must be presented with the bids.

The Department reserves the right to reject any and/or all bids.
