

## Effective August 1, 2017:

Lettings on or after August 1, 2017: all bidding will use the Expedite 5.11a-1 software. You will have two methods to submit a bid:

- 1) Printed signed proposal with a priced bid form printed from Expedite and submitted to the Division with a CD/flash drive containing the priced EBS file.
- 2) Bid submitted through Bid Express® using Expedite. You will need a NCDOT Divisions Digital ID to bid.
