DEPARTMENT FURNISHED MATERIALS

The Department will furnish the following surplus materials to be utilized in completing the work associated with this project;

In the event these materials are unusable, the Contractor will supply necessary materials for this project. The Department will remove and dispose of non-utilized materials from the above list. The Contractor is advised to inspect these materials for applicability prior to bid.

No direct payment or credit will be made for the Department furnishing the above referenced materials. The Contractor shall adjust the Unit Price Bid for Line Items where these materials are utilized.

General

Schedule and conduct construction activities in a manner that will minimize soil erosion and the resulting sedimentation and turbidity of surface waters. Comply with the requirements herein regardless of whether or not a National Pollution discharge Elimination System (NPDES) permit for the work is required.

Establish a chain of responsibility for operations and subcontractors' operations to ensure that the *Erosion and Sediment Control/Stormwater Pollution Prevention Plan* is implemented and maintained over the life of the contract.

- (A) *Certified Supervisor* - Provide a certified Erosion and Sediment Control/Stormwater Supervisor to manage the Contractor and subcontractor operations, insure compliance with Federal, State and Local ordinances and regulations, and manage the Quality Control Program.
- (B) *Certified Foreman* - Provide a certified, trained foreman for each construction operation that increases the potential for soil erosion or the possible sedimentation and turbidity of surface waters.
