Reference is made to the proposal and plans previously furnished for this project.

The following revision has been made to the proposal and plans:

Page No. 27A, A special provision for a "Fully Operated Bulldozer" has been included to illustrate the Contractor's responsibilities for this line item. Please insert Page No. 27A in the previously provided document.

Page No. 85, "Bid Form" has been revised to include a line item for "General Miscellaneous Item (Fully Operated Bulldozer)." Please void existing Page No. 85 and staple revised Page No. 85 thereto.

Plan Sheet No. 2 "Typical Section" has been revised to properly show the distance from the existing edge of pavement to the proposed toe-of-slope on the seaward side of the proposed dune. Please void existing Plan Sheet No. 2 and staple the revised Plan Sheet No. 2 thereto.

Plan Sheet No. 3 "Summary of Quantities" has been revised to include a line item for a "Fully Operated Bulldozer". Please void existing Plan Sheet No. 3 and staple the revised Plan Sheet No. 3 thereto.

FULLY OPERATED BULLDOZER:

The Contractor will be responsible for providing a fully operated bulldozer to perform various grading activities at the NCDOT Ferry Dredge Spoil Site. These activities shall include, but will not be limited to; creating a berm to separate existing spoil material and proposed dredge spoil and pushing newly reclaimed dredge spoil material to be utilized in the dune reconstruction process. Grading of the access road is not included under this provision as this work is incidental to *Grading (Lump Sum)*.

Description

The Contractor shall furnish equipment in good operating condition and operated by properly trained and qualified personnel. The personnel operating the equipment shall be the responsibility of the contractor and the contractor shall be responsible for employees during the performance of the contract. Subcontractors may be permitted under this agreement with prior approval of the Engineer. The personnel shall be subject to the directions of the Department of Transportation. The Department of Transportation may refuse delivery or may return any equipment found to be defective and/or inadequately operated.

Contractor shall be responsible for all costs or charges incurred in the operation and maintenance to the equipment during the contract period.

Measurement and Payment

Payment for *Generic Miscellaneous Item* (*Fully Operated Bulldozer*) shall be made on an hourly basis in accordance with the rates set out in this contract. All charges shall be determined to the nearest one-quarter (1/4) hour based upon the time the equipment was in actual productive operation. The contractor will not be paid for downtime due to meals, equipment failure, unsatisfactory weather, nor any other conditions.


