The scope of work for this project will include **the construction of approximately 538 linear feet of sill with approximately 64 linear feet of alternate sill options as part of the MOOR SHORE LIVING SHORELINE PROJECT** located in Kitty Hawk, North Carolina.

Contractors are notified that North Carolina G.S. 87 relating to licensing of contractors will be observed in receiving bids and awarding contracts. General Contractor shall be a qualified and properly registered Highway Contractor.

Small Business Entities, Women Owned Businesses and Minority Owned Businesses are encouraged to submit bids.
