National Bridge Builders, LLC has been awarded the above-mentioned project. Your bid proposal **did not** indicate adequate participation to satisfy the advertised combined MBE/WBE goal of 6.0%.

Your bid proposal indicated that your firm attained the following participation:

Combined MBE/WBE Goal = 3.06%

Your firm's request for a withdrawal of banked funds to meet the combined MBE/WBE participation goal shortfall has been approved.

The combined MBE/WBE Goal Commitment of 3.06% and the withdrawn banked funds in the amount of **\$24,809.09** will be the Contract Goal Requirements.

Based on your bid proposal, the Department has approved the following prequalified MBE/WBE subcontractors and dollar amounts to meet the contract goal requirements. 
