The date of completion for this project is March 31, 2016 with an option to renew this contract for two (2) additional one-

year periods.

The North Carolina Department of Transportation is requesting bids for the above mentioned project. Interested bidders must obtain an official bid package in order to bid. Contractors and subcontractors may obtain a proposal and plans from the Division10 website at: http://www.ncdot.org/doh/operations/division10/ or in person from the Interstate Maintenance Office, 12033 East Independence Blvd. Matthews, NC 28105.

Contractors must be pre-qualified with NCDOT as Bidder or PO Prime Contractor prior to bidding on this project. Information about prequalification can be found at https://connect.ncdot.gov/business/prequal/pages/default.aspx

It will be the Contractor's responsibility to continue to monitor the NCDOT website for any addendums or other updates concerning this project.
