Sealed bids must be received in the Division Engineer's Office at 716 W. Main Street in Albemarle NC by **2:00 PM Wednesday April 5, 2017**. Paper Bids must be submitted using the bid sheet contained within the Contract Proposal and must be submitted with the entire Contract Proposal.

Electronic Bidding through Bid Express® is acceptable. **Do NOT submit your bid for the project let by Division 10 to the NCDOT Statewide Project Letting Office.** 

Electronic Bid Preparation with Manual Delivery is also acceptable.
