It will be the Contractor's responsibility to continue to monitor the NCDOT website for any addendums or other updates concerning this project.

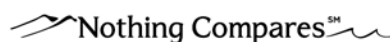

Bids that are not submitted electronically must be submitted using the bid sheet contained within the official Contract Proposal and must be submitted with the entire official Contract Proposal. 
