Bids that are submitted by Electronic Bid Preparation with Manual Delivery must also include the entire Contract Proposal hard copy, the hard copy printout of the electronic bid sheet, the hard copy printout of the electronic subcontractors sheet, and the hard copy printout of the signature page. All required signatures and seals must be included on the bid sheet that is contained within the official Contract Proposal.

Bids that are submitted with Manual Delivery must be received in the Division Engineer's Office at 716 W. Main Street in Albemarle NC by **2:00 PM Wednesday September 6, 2017** and must display the following statement at the bottom left corner of the sealed envelope:
