Electronic Bidding is acceptable.

As of September 7, 2016 Division 10 can accept electronic bids through Bid Express®. **Do NOT** submit your bid for the project let by Division 10 to the NCDOT Statewide Project Letting Office.

Electronic Bid Preparation with Manual Delivery is also acceptable. Bids that are submitted by Electronic Bid Preparation with Manual Delivery must also include the entire Contract Proposal hard copy, the hard copy printout of the electronic bid sheet, the hard copy printout of the electronic subcontractors sheet, and the hard copy printout of the signature
