It will be the Contractor's responsibility to continue to monitor the NCDOT website for any addendums or other updates concerning this project.

Sealed bids must be received in the Division Engineer's Office at 716 W. Main Street in Albemarle NC by 10:00AM Wednesday October 7, 2015. Bids may be submitted digitally via disc using the Expedite 5.9a software that can be downloaded at the following location: http://stage.dot.state.nc.us/doh/operations/division10/Projects.html. Bids that are submitted electronically must also include the entire Contract Proposal hard copy, the hard copy printout of the electronic bid sheet, the hard copy printout of the electronic subcontractors sheet, and the hard copy printout of the signature page. All required signatures and seals must be included on the bid sheet that is contained within the official Contract Proposal. Bids that are not submitted electronically must be submitted using the bid sheet contained within the official Contract Proposal and must be submitted with the entire official Contract Proposal. All bids must display the following statement at the bottom left corner of the sealed envelope:
