Sealed bids must be received in the Division Engineer's Office at 716 W. Main Street in Albemarle NC by **2:00 PM Wednesday October 19, 2016**. Paper Bids must be submitted using the bid sheet contained within the Contract Proposal and must be submitted with the entire Contract Proposal.

Electronic Bidding is acceptable.

As of September 7, 2016 Division 10 can accept electronic bids through Bid Express®. **Do NOT** submit your bid for the project let by Division 10 to the NCDOT Statewide Project Letting Office.

Electronic Bid Preparation with Manual Delivery is also acceptable. Bids that are submitted by Electronic Bid Preparation with Manual Delivery must also include the entire Contract Proposal hard copy, the hard copy printout of the electronic bid sheet, the hard
