Description: "As needed" Contract for Pipe Rehabilitation with Cured In Place Pipe Liner and

Cementitious/Geopolymer Spray On Pipe Liner

Addendum No. 1 November 3, 2021 Letting

To: Prospective Bidders

The Department has received questions concerning the above-mentioned project. Please note the question and answer provided below:

- **Q.** Is GeoTreeSolutions the only cementitious/geopolymer spray on pipe liner on the NCDOT Approved Products List?
- A. No, the following products are approved on the NCDOT approved products list.
  - o GeoTreeSolutions GeoSpray Geopolymer Mortar
  - o Five Star Products Five Star Centri Cast Pipe Repair Mortar
  - AW Cook Cement Horizontal Pipe Lining Mortar Silatec MSM HP
- A. Additionally there are some products with a provisional approval which will require additional approval by the Engineer and the Materials & Test Unit prior to use. Request to use these materials may or may not be approved as approval will be based on the individual site conditions, etc.
  - o Standard Cement Materials Geocast
  - o JW & Associates 8K plus Structural Cement
  - Nukote Coating Systems Aegis Spray-applied Pipe Liner
- **Q.** What is the estimated budget for this project?
- A. This contract will be used on an "as needed" basis as we locate failing pipe. Typically we have 2 or 3 large diameter pipe 54"-72" that need to be repaired as well as a several smaller storm drain pipes each year.
- Q. What are the debris disposal requirements?
- A. See "Construction materials management" provision beginning on page 43. The contractor will be responsible for cleanup and disposal of waste from their operation in accordance of the contract.
- Q. Has the owner had projects of similar scope to this in the past?
- A. Yes
- Q. Are there any CCTV Videos available of the project area?
- A. In some case's there may be video. But there's a line item for CCTV Inspection if we expect your firm to do pipe investigation. Also, pre-installation video and post-installation

videos are required as part of the Pipe Rehabilitation line items. These videos are incidental as the cost of such is included in the rehabilitation line items.

- Q. Does the Post CCTV Video need to be done after the Manhole Rehab?
- A. Manhole Rehabilitation is not part of this contract.
- Q. Items 9-17 call for Spray liner, can Cured In Place Pipe Liner be considered for these diameters?
- A. In some cases we may require a Spray Liner. The NCDOT may consider other alternative treatments as long as the treatment is of a similar quality and cost is comparable to a spray liner.

The changes and attachments included with this addendum will become part of contract 10-00-173.
