It will be the Contractor's responsibility to continue to monitor the NCDOT website for any addendums or other updates concerning this project.

The Contractor shall provide the Department with three (3) projects, including references and contact information, where pipe culvert rehabilitation as described in the contract proposal was successfully performed within the past three (3) years. This information shall be submitted with the bid package.


