REMOVAL OF EXISTING TRAFFIC SIGNAL

Revise the Standard Specifications as Follows:

Page 17-43, Article 1757-3 Measurement and Payment, Replace paragraph with the following:

Traffic Signal Removal will be measured and paid as the actual number of intersections that were maintained and completely cleared of all traffic signal equipment. The above price and payment will be full compensation for all work covered by this provision, including but not limited to removal, disposal and maintenance of the traffic signal during the life of the project. The contractor shall return the removed signal to the Traffic Services Office as stated in 1757-2 (C) and will be of no cost to the department.
