QUESTIONS AND ANSWERS

1. The Pavement Repair with Milling detail on Sheet 2A states 8" Asphalt Patch (Min.) or as shown in pavement schedule. Is the Contractor to follow the pavement schedule on Sheet 3 which includes 8" of Base, 4" of Intermediate, and 3" of Surface? Will this work be paid under the corresponding line items for each mix?

Answer: Pavement Repair with Milling Detail:

This standard City detail is used for pipes installed under existing pavement, such as when the pipe is perpendicular to an existing road. Pavement repair is incidental to other work, so no additional payment will be made for asphalt mix in these locations. The pavement schedule shown in the detail is the minimum allowed, but the contractor can also follow the pavement schedule on Sheet 3.

2. Plan Sheet 28 shows the RCP run from structure 2802 to structure 2803 being 18" RCP IV. However, the Drainage Summary Table on Plan Sheet 3D shows that same run being 24" RCP IV. Please advise.?

<u>Answer:</u> There is a typo on the summary sheet. The pipe should be a single 18" RCP as shown on the plan. Please review updated Plan Sheet 3D.

3. To clarify, the entire bid manual is to be submitted at the time of bid? All signed forms can be submitted separately from the manual itself inside the portal?

Answer: Yes, the bid manual is to be submitted at the time of bid and yes all signed forms can be submitted separately from the manual.

4. Estimated quantity for borrow?

Answer: Lump Sum- Designer to provide more information.

5. Utility relocate schedule provided?

Answer: A Utility relocation schedule is not available.

6. NCDOT Interest Party Required for submittal?

Answer: Encouraged, but cannot confirm at this time that it is a requirement. Contractor is responsible for checking with NCDOT on their requirements.
