#### 1.0 GENERAL

The work shall consist of fabricating, furnishing, assembling and installing the following mockups, as shown in the contract documents and as directed by the Engineer. The work shall include providing temporary supports for the mockup.

- 1. Concrete deck finish, including protective sealing
- 2. Arch with cable connection plate, including painting, with cable and socket
- 3. Fabricated deck edge, including railing connection plate and cable connection plate
- 4. US Bank sign for color, texture, and material approval.
  - a. Color to be selected from manufacturer's standard offerings.
  - b. Match the architectural renderings.
- 5. Concrete Bench for color and texture approval.
  - a. Color to be selected from manufacturer's standard offerings
  - b. Match existing or architect's sample
  - c. Custom Sample Number

- a. Initial selection: for products involving selection of color, texture, or design.
- b. Samples for Verification: For each type of exposed finish required.
  - i. Sections of each distinctly different linear railing member, including handrails, top rails, posts, and balusters
  - ii. Fittings, end caps, and brackets.
  - iii. Assembled Sample of railing system, made from full-size components, including top rail, post, handrail, and guard infill. Sample need not be full height.
    - 1. Show method of connecting and finishing members at intersections and at transitions between angled and straight segments.

#### 2.0 MATERIALS

As specified in the respective sections of the specifications.

#### 3.0 PRECONSTRUCTION METHODS

#### A. SUBMITTAL:

- 1. Mockup plan: copy of proposed location for each mockup
- 2. Shop drawings: clearly identify components and materials to be integrated into the assembly. Integrate material finishes and any temporary supports required to keep the mockup stable.
- 3. Structural calculations: to ensure structural integrity of the mockup. Calculations to be signed by a licensed professional structural or civil engineer.
- 4. As-Built shop drawings: changes based on accepted mockup shall be incorporated into final as-built shop drawings.

#### B. MOCKUP FOR CONCRETE DECK SURFACE:

Mockup size shall be a minimum of 10ft x 10ft.

Mockup to be used for review of appearance, workmanship and quality of the concrete deck finish. Information for concrete deck and finishes as shown in the contract documents. Contractor has the option to propose equivalent product with same quality and appearance. This should be demonstrated on a separate mockup for comparison.

#### C. MOCKUP ARCH AND CABLE PLATES:

Mockup size shall be a 10 foot long section of the arch pipe incorporating a typical two-cable connector plate (e.g. the North Arch either side of gridline 11)

Material finishes and requirements for architectural exposed steel and others as specified in the contract documents.

#### D. MOCKUP FABRICATED DECK EDGE AND CONNECTING PLATES:

Mockup size as shown in contract documents.

#### 4.0 CONSTRUCTION METHODS

Build mockups in situ and of size and profile indicated or, or as directed by the Owner.

Notify the Owner, Construction Manager, and Engineer 7 days in advance of dates and times when mockups will be constructed and able to be inspected.

Employ supervisory personnel to oversee mockup construction. Employ same workers that will be employed during the construction of Project.

Demonstrate the proposed range of aesthetic effects and workmanship.

Commence the Work after the mockup has been inspected and approved in writing by the Owner.

The mockup will establish the standard of quality of workmanship by which the Work will be judged.

Maintain mockups during construction in an undisturbed condition as a standard for judging the completed Work. Failure to maintain the mockup, until directed, will be cause for rejection of the Work.

Any railing parts and light fixtures from mockup can be incorporated into the final bridge design if approved by the Owner or Engineer.

#### 5.0 MEASUREMENT AND PAYMENT

This work will be measured by each individual mockup and shall be priced separately.

The lump sum price of each mockup shall include the cost of furnishing all labor, materials, equipment and incidental expenses necessary to satisfactorily complete the work.

### **QUESTIONS AND ANSWERS**

1. Is ASTM A1094 Galvanized Rebar an acceptable substitute for the ASTM A767 requested on the structural notes on sheet S-1?

Answer: This is acceptable.

2. Is the Galvanized rebar only for the bridge deck or also for the substructure?

Answer: Galvanized rebar is only for the bridge deck to reduce the concrete cover requirements.

3. Will a specific factor of safety be required for the crane, due to our proximity to the rail line? if so, what value or percentage?

Answer: CATS does not require additional safety factors beyond the standard statutory requirements.

- 4. A) Regarding mockups. SP-12 only mentions the 3 following mock ups:
  - a) -Concrete deck finish including protective sealing
  - b) -Arch with cable connection plate, including painting with cable and socket
  - c) -Fabricated deck edge, including railing connection plate and cable connection plate.
  - B) The excel quantities have 10 mockups listed, which are the other 7 mockups?

#### Answers:

- A) SP-12 has been revised above in this addendum.
- B) The Itemized Bid spreadsheet is revised with this addendum to show the quantity of 6.
- 5. Due to freight or shipping constraints, most likely the arches will be shipped in two halves (8 pieces total) requiring a field weld about mid arc, to join them in the staging area. The plans do not show any field welds in the arches. Will each of the arches be allowed to be shipped in 2 halves?
  - <u>Answer</u>: Yes this is acceptable. Welds need to be complete joint penetrations and detail needs to be provided to the Engineer of Record for review and approval.
- 6. Drawing S-3 calls out the hanger cables to be PG-40 cables and the specs give DIN specification numbers. PG-40 cables under DIN specifications are not US based products. To the best of our knowledge, these are German made products. Since the Buy American Act applies to this project, please provide an alternate model number of specification in which to comply with.
  - <u>Answer</u>: Cables that consist of: Spiral Strand built up, breaking load of > 367kN = 82.4kip and open swaged fitting connectors are acceptable. Products to be submitted to Engineer Of Record for review and approval.
- 7. Our rebar supplier has requested to see the engineer would approve the use of the Galvabar product, it is what is currently being spec'd for SCDOT projects. It is ASTM A1094 vs A767 that is being spec'd for this project. It is simply a different process of galvanizing which allows them to fabricate after the bar is galvanized. Please advise.

Answer: NCDOT has not approved this product yet, so this is not an acceptable substitution.
