It will be the Contractor's responsibility to continue to monitor the NCDOT website for any addendums or other updates concerning this project.

There will be a Mandatory Pre-Bid at 10:00 AM Thursday November 15, 2018 at the Interstate Maintenance Office located at 12033 East Independence Blvd, Suite I Matthews NC, 28105. All bidders are required to attend this meeting.

Electronic Bidding is not available for this contract.
