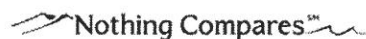
It will be the Contractor's responsibility to continue to monitor the NCDOT website for any addendums or other updates concerning this project.

Sealed bids must be received in the Division Engineer's Office at 716 W. Main Street in Albemarle NC by **2:00 PM Wednesday December 21, 2016**. Paper Bids must be submitted using the bid sheet contained within the Contract Proposal and must be submitted with the entire Contract Proposal.

Electronic Bidding through Bid Express® is acceptable. **Do NOT submit your bid for the project let by Division 10 to the NCDOT Statewide Project Letting Office.**

Electronic Bid Preparation with Manual Delivery is also acceptable. If you wish to submit your bid in this manner, please submit them via CD or USB flash drive using the Expedite 5.9a software that can be downloaded at the following location: <https://connect.ncdot.gov/letting/Pages/EBS-Information.aspx>

Bids that are submitted by Electronic Bid Preparation with Manual Delivery must also include the entire Contract Proposal hard copy, the hard copy printout of the electronic bid sheet, the hard copy printout of the electronic subcontractors sheet, and the hard copy printout of the signature page. All required signatures and seals must be included on the bid sheet that is contained within the official Contract Proposal.
