



## **INVITATION TO BID (REBID)**

The City of Lenoir will be receiving bids for the project titled *EB-5806 Hospital Avenue Sidewalk*.

Sealed Bids will be received by the Public Works Office for the City of Lenoir (OWNER) located at 510-B Greer Circle, North Carolina 28645, until **February 27, 2025, 2:00 pm**, for EB-5806 Hospital Avenue Sidewalk from Harper Avenue to US 321 (Blowing Rock Blvd.).

A pre-bid meeting will be held on Thursday, February 20, 2025, at 2:00 P.M. at the City of Lenoir Public Works Facility, 510-B Greer Circle, SW, Lenoir, NC 28645. Attendance at this meeting is NOT mandatory but is strongly encouraged

**The proposals will be opened promptly and read aloud at the City of Lenoir Public Works Facility, 510-B Greer Circle, SW, Lenoir, NC 28645.** All bidders and the public are invited to attend the bid opening.

The proposed work is generally described as follows:

**This contract is for installation of drainage, sidewalk, retaining walls and signal work in the City of Lenoir. The Contractor shall furnish all labor and materials for the project in accordance with the NCDOT 2024 Standard Specifications and/or Special Provisions.**

The bid package will be sent via email to the requesting Contractor or a link will be given to access the bid package online.

Bidders are required to be prequalified with NCDOT as Bidders or PO Prime Contractors prior to submitting a bid. Information regarding prequalification can be found at: <https://connect.ncdot.gov/business/Prequal/Pages/default.aspx>.

Bids will be received on a unit price basis, evaluated and awarded per the 2024 NCDOT Standard Specifications.

Upon confirmation of the lowest responsible bidder, the City will give the Successful Bidder a Notice of Award. The Successful Bidder will be required to furnish Construction Performance and Payment Bonds as security for the faithful performance and the payment of all bills and obligations arising from the performance of the Contract.

No exceptions, unrequested additions, deletions, purported clarifications, and/or any other types of modifications of the proposed forms, terms, conditions, and specifications may be submitted with the bid package. No information/documentation beyond what is specifically requested is to be submitted. Any bid containing such exceptions or modifications will be deemed non-responsive, and, accordingly will not be considered. The City of Lenoir reserves the right to reject any and all bids.
